The proposed Tulare County General Plan 2030 Update (General Plan Update) amends the existing Tulare County General Plan to provide a comprehensive update in three parts. Part I, Goals and Policies Report, Part II, Area Plans are substantially revised. Part III is revised to make two modifications to existing plans: (1) the County adopted City General Plan for Dinuba is modified to reflect the recently annexed Dinuba Golf Course, residential and wastewater treatment area, and (2) the Pixley Community Plan, is modified to include Harmon Field (a closed airfield).
