If used, this paragraph should be a footnote in the FGMP.

Updated or Deleted Sections and Elements, Page 1-7

- 1) Date in first line of first paragraph should be changed to 2012.

Section 1.6 Cross Element or Chapter Considerations

- 1) Date in the first line of the second paragraph should be changed to 2012
- 2) Delete “also” in the fifth line of third paragraph

Chapter 2. Planning Framework

Section 2.2 Communities, Page 2-10

- 1) Policy PF-2.3: add phrase “to comment” after “other service providers”

Section 2.4 Cities, Page 2-52

- 1) Introductory sentence: Update PF-4.12 reference to PF-4.16

Section 2.9 Work Plan/Implementation Measures

- 1) Update Policy references under “Implements what Policy” to reflect reordered Policies in Section 2.4 Cities.

Chapter 3. Agriculture

Existing Conditions Overview, Page 3-4

- 1) "I" Box: add "amended" after "is not being" in sixth line.

Section 3.1 Agriculture Preservation, Page 3-4

- 1) Policy AG-1.3: Add "and HDBs" at the end of the first sentence

Section 4.2 Resource Uses, Page 4-26

- 1) Policy LU-2.1: Delete "and" in the first line

Water, Page c-3

- 1) After Principle 5: delete language referencing the "Animal Confinement Facilities Plan (ACFP) Phase I"

Chapter 8. Environmental Resources Management

Section 8.4 Energy, Page 8-15

- 1) Policy ERM-4.7: Add "The County shall" to the beginning of the policy.

Chapter 9. Air Quality

Section 9.4 Air Pollution Control, Page 9-11

- 1) Finish Policy AQ-4.6 by adding Implementation Measure 15.

Chapter 10. Health & Safety

Assembly Bill 162 (2007 Ca.Stats. 369) and Senate Bill (2007 Ca.Stats. 364)

- 1) Substitute in Figures 10-1 and 10-2, copies attached, showing underlying information in UABs and HDBs
